SEPARATE STANDARD WITHDRAWAL FORM TO FACILITATE THE RIGHT OF WITHDRAWAL

(Annex to: PURCHASE AGREEMENT)

Withdrawal Right

The consumer has the right to withdraw from this agreement within fourteen calendar days, without giving any reason.

The withdrawal right starts on _____ (to be completed by the trader before handing over the form to the consumer).

If the consumer has not received this form, the withdrawal period shall start on the date when this form is delivered to the consumer, but, in any event, the period shall expire after one year and fourteen calendar days.

If the consumer has not received all the information required, the withdrawal period shall start on the date when the consumer receives such information, but, in any event, the period shall expire after three months and fourteen calendar days.

In order to exercise his/her withdrawal right, the consumer shall send a notice to the trader according to the following requirements:

For the purposes of serving notice, all communications shall be addressed to the registered office of the Company, at: Avenida España, Número 3, HOTEL FLAMINGO, Urbanización San Eugenio-Playa de las Américas, CP 38670 Adeje, Santa Cruz de Tenerife, Spain.

Any notice or communication that may or shall be made in order to exercise the withdrawal right, shall be made in writing and, at the option of the consumer, by means of registered fax, telegram or registered letter with acknowledgement of receipt, or optionally, through a notary office. All notices or communications shall be considered validly made on the date of their delivery.

If the consumer avails himself/herself of the withdrawal right, no cost shall be charged to him/her.

The consumer may use the following form, although it is not mandatory:

Prohibition on advance payments

During the withdrawal period, the consumer is not permitted to make any advance payments. This prohibition extends to any consideration, including payment, provision of guarantees, reservation of money on accounts, explicit acknowledgement of debt, etc.

This includes not only payments to traders, but also to third parties.

This document is drawn up in Spanish and English, as it is the mother tongue of the purchaser. The document has been translated by a sworn translator. The original sworn translation is filed with the Property Registry of Adeje. In case of inconsistency between both versions, the Spanish version shall prevail.

By signing this document I /we acknowledge that I/we have been informed, sufficiently in advance, of the conditions to exercise the right of withdrawal and of the prohibition on advance payments, that I/we have read, understood, and to which I/we agree. In witness whereof, I/we sign this document.
